

# Development of the Australian Code for the Responsible Conduct of Research, 2018

The *Australian Code for the Responsible Conduct of Research, 2018* (the 2018 Code) and supporting document, the *Guide to Managing and Investigating Potential Breaches of the Code 2018* (the Investigation Guide) has been jointly developed by National Health and Medical Research Council (NHMRC), the Australian Research Council (ARC) and Universities Australia (UA) (collectively, 'the co-authors').

The review of the Code was assisted by the Code Review Committee (CoRC), chaired by Professor Mike Calford. The Investigation Guide was developed with advice from the Better Practice Guides (BPG) working group, which was chaired by CoRC member Dr Karolyn White.

## Consultation

The development of the 2018 Code and accompanying Investigation Guide was informed by extensive consultation with the sector.

In 2015, the co-authors undertook a targeted consultation on the 2007 Code and possible models for a revised document. As a result of the targeted consultation, the co-authors streamlined the 2007 Code into a principles-based document that would be supported by supplementary guidance that provides detailed, topic-specific advice and requirements for conforming to the principles and responsibilities of the Code.

Public consultation on the draft Code and Investigation Guide was conducted between November 2016 and February 2017. Background material can still be accessed from the [NHMRC Public Consultation website](#). Around 90 submissions were received during public consultation on the review of the Code. The CoRC and BPG working group considered all the comments received during public consultation and provided advice to the co-authors about revisions to the Code and Investigation Guide.

In late 2017, NHMRC, ARC and UA engaged in a final, targeted consultation with the sector.

## The Code Review Committee (CoRC)

The CoRC was established under section 39 of the *National Health and Medical Research Council Act 1992* (NHMRC Act). Members were selected to ensure appropriate expertise in the key areas of research integrity, administration and management across a range of different research institutions and research disciplines.
